- **New Physicians at Dayton Children's - Dr. Jason Daume** has joined the Children's Anesthesia group and will begin caring for patients in April 2012. **Dr. Stacy Meyer** has joined the department of Endocrinology and will begin seeing patients in the fall of this year. **Dr. Arun Aggarwal** is in a GI fellowship in New York. He has committed to joining the GI department here and will begin working in Dayton in July 2013. **Dr. Nicole Tocco** joined the neonatology group here and is already caring for patients at Dayton Children's. **Dr. Salim Mancho** will be working part time in the department of Plastic Surgery and begin seeing patients in Summer 2012. **Dr. Matt Garrett** has joined the Southwest Ohio ENT Specialists and will begin caring for patients at Dayton Children's in August 2012. A pediatric orthopedist has given a verbal commitment to join the group here in Dayton. Dayton Children's is committed to having 7 pediatric neurologists and 6 pediatric gastroenterologists. They are also planning to hire 3 pediatric anesthesiologists in the coming months.
 - **Mary Poppaw, RN** has decided to move to Home Health Care nursing. Her last day in the department is this Friday, February 24. The process for interviewing candidates for her replacement has begun.
 - **Daily Huddle** – Joanne Hand and the managers for each area in Medical Imaging meet each morning at 9:30 am for 15 minutes to review the schedule, no show patients, rescheduled patients, add on procedures, staffing issues, and equipment status. I also attend the meeting. Melanie Wilson and Barb Justice from scheduling call in each morning. This quick opportunity to hear what is going on has proven to be helpful for planning the day and giving each other a heads up for patient safety.  - **Sugarcreek Testing Center** – A new satellite center will open in Sugarcreek during spring 2012. That site will have hours and services similar to Kettering and Beavercreek Testing Centers with lab, x-ray, and ultrasound on certain days.
