4. Ongoing Professional Practice Evaluation (OPPE) E. Ey

 - i. Peer Review
 - ii. Turnaround Time (TAT) Stat CT exams
 - iii. TAT Stat Conventional radiographs
 - iv. Timely signing of Reports

Note: Keith Jones will assist with the calculation of metrics ii, iii, and iv above.

c. In addition to these metrics, a periodic (every six months) review with the Medical Director is also required.
